Activity Logs 4/8/2024 – 4/29/2024

- 1. On 4/9 at 0951 hours received a complaint of harassment from a resident in the area of Chandler road. Allegations were investigated, suspected contacted and warned relative to the harassment and possible criminal threatening. Case suspended at this time.
- 2. On 4/13 at 2030 hours received a canine nuisance complaint from a citizen in the area of Greenfield road. The canine's owner was identified and this case is pending, as it was found to be an on-going issue.
- 3. On 4/13 at 2359 hours received a simple assault complaint in the area of Mountainside Lane and also requesting an ambulance. State police advised.
- 4. On 4/15 at 1220 hours received an intake from Division of Children, Youth and Families relative to an allegation which was reported to the Conval High school Social Worker. He allegation indicated alleged sexual abuse. Investigation is continuing.
- 5. On 4/15 at 1803 hours received a complaint in the area of Greenfield road of canines barking and being a nuisance for several hours and that this is an on-going issue with the neighbors. Investigation on-going.
- 6. On 4/16 at 1007 hours received a report of an attempted scam pertaining to a telephone call to the complainant about a grandchild being arrested and that bond was needed. The complainant did not disclose any information.
- 7. On 4/17 received a residential alarm in the area of Dennison Pond road. State police advised.
- 8. On 4/19 at 1414 hours received an intake complaint from Division of Children, Youth and Families relative to an allegation pertaining to a child. Investigation is on-going.

- 9. On 4/20 at 1520 hours received a complaint of a landlord/tenant dispute in the area of Bennington road. Further investigation was conducted and it was determined that it was a civil issue and all parties involved were informed. Cleared.
- 10.On 4/22 at 0729 hours responded to Slip road in Greenfield under mutual aid for a report of a suspicious subject/vehicle complaint. Upon arrival contact was made with the subject. Back-up officers responded to the scene. After further investigation, the operator was issued summonses, another person responded and removed the vehicle in question. Cleared at 0900.
- 11.On 4/22 at 1138 hours received a report of a canine nuisance complaint in the area of Greenfield road. The person responsible for the canine's nuisance was spoken with about the complaint. The complainant was spoken with and advised of the status of the complaint. Cleared.
- 12.On 4/22 at 1330 hours responded to Camirand Car Care on Oak Hill road for a VIN inspection. Conducted the inspection and cleared.
- 13.On 4/23 at 0656 hours responded to the area of Mountainside Lane for paperwork service being a No Trespass Order from the Webster Police department. The order was issued to the person of interest. Cleared.
- 14.On 4/23 at 1120 hours escorted complainant to the area of Bennington road for a civil escort in order to obtain some personal items. Responded to the location and stood-by while items were removed. Cleared.
- 15.On 4/24 at 1140 hours received a complaint of disorderly conduct and or criminal threatening from a resident relative to allegedly the suspect, who was identified continues driving by his place of work and expressing physical gestures, blowing his horn and stopping and impeding traffic. Further the complainant went to the suspects residence where allegedly the suspect verbally threatened him with a firearm. Investigation pending.
- 16.On 4/24 at 1433 hours received a mutual aid request through the Milford Communications Center in Milford to respond to 2nd New Hampshire Turnpike in Mont Vernon to back-up the Mont Vernon officer on a motor vehicle stop. Further investigation indicated that the male operator had confronted several residences and allegedly was soliciting sex along the 2nd New Hampshire Turnpike. Assisted the Mont Vernon along with other officers. Cleared at 1502 hours.
- 17.On 4/24 at 1650 hours responded to Scoby road to conduct a VIN inspection for a citizen. Conducted same and cleared.

- 18. On 4/25 at 1400 hours received a report of a theft in the area of Perley road. This was a result of a sale of a vehicle and the purchaser was from Utica New York. It was reported that the seller was shorted \$2,000.00 when she counted the cash and the license plates were also allowed to go with the vehicle at the time of the sale. As this investigation was proceeding, the complainant called and advised that she had spoke with the purchaser who advised that he would send the registration plates back to her. Complainant did not wish to pursue the investigation any further as she was taking responsibility for not counting the money properly. Investigation closed.
- 19.On 4/25 at 1600 hours received a report of a lost canine out of New Boston on New Boston road. The information was taken and disseminated, however at 2000 hours it was reported that the canine had been located.
- 20.On 4/27 at 1100 hours received a report of a teenager operating a vehicle on 4/26 with loud exhaust on Journeys End road and spinning the tires while turning multiple times and digging up the dirt roadway that the Francestown Highway Department had just graded. Possible known subject and further investigation to will be conducted.
- 21.On 4/27 at 2151 hours received a report of a motor vehicle collision with a whitetail deer however the operator was not familiar with the area and was unsure where he was. E911 notified who assisted with determining the location.
- 22.On 4/28 at 1533 hours received a motor vehicle complaint of excessive speed in the area of Marino road. Investigation is continuing.
