Board of Selectmen Minutes of Meeting Monday, February 11, 2019

Mr. Howell called the meeting to order at 5:33 PM.

Mountain Maintenance, represented by John Perry and Al Bell, came to the Board to hear the decision resulting from the two public hearings regarding the East Road ROW correction. Mr. Kunhardt moved to accept the proposed Right of Way Correction Plan East Road Paper R.O.W. dated 12/27/18 as revised 1/10/19. Ms. Arnold added to the motion that this was an exchange of land with no monetary gain or loss. Mr. Howell seconded the motion. **Motion passes**.

There was some discussion of the next step for Mountain Maintenance which involves an application to the Planning Board to be signed by the Selectmen.

Ms. Arnold suggested that the Board set up a meeting with the Planning Board, before Town Meeting, to determine the area to be designated in RSA 79-E. It was decided to wait and see if RSA 79-E gets passed at Town Meeting before determining area.

Ms. Arnold suggested that the Board designate one Monday of the month, with no appointments, to be dedicated to discussing bigger issues facing the Town, such as parking and the future of the school. On a trial basis the Board will try and do this the 2nd Monday of the month.

Ms. Arnold wondered about a time to meet with the Old Meeting House to settle questions about land ownership. Mr. Pike is to set that up soon.

Mr. Pike offered the Board two covers for the upcoming Town Report. They agreed on one with some tweaks to color and formatting.

A motion was made by Ms. Arnold and seconded by Mr. Kunhardt to enter into a nonpublic session pursuant to RSA 91-A:3, II(c) at 6:03 pm. Howell, Aye; Arnold, Aye; Kunhardt, Aye **Motion passes.**
