# First Human Case of Eastern Equine Encephalitis

#### NH Department of Health and Human Services (NH DHHS) recommends the following:

- 1. Awareness of the first identified human infection with Eastern Equine Encephalitis (EEE) virus in New Hampshire in 2014.
  - Vigilance is needed during the summer months to consider mosquito-borne diseases, including West Nile Virus (WNV) and Eastern Equine Encephalitis (EEE) in patients with compatible clinical features.
  - Laboratory testing may be arranged by calling 603-271-4496 during business hours or 1-800-852-3345 ext. 5300 after hours.

- 2. Advise patients and residents to use prevention measures to avoid mosquito bites by protective clothing, insect repellents, and reducing environmental mosquito populations.
- 3. Report suspected and confirmed cases of mosquito-borne diseases to the Bureau of Infectious Disease Control at 603-271-4496 (after hours 1-800-852-3345 ext. 5300).

#### **Epidemiology:**

The New Hampshire Division of Public Health Services (NH DPHS) has identified a human case of neuroinvasive Eastern Equine Encephalitis virus (EEEv) in an adult who resides in Conway, NH. This individual became ill on August 13, 2014, and is believed to have acquired illness in the Conway, NH, area and is currently hospitalized in critical condition.

To date, EEEv has been detected in 5 mosquito batches this year in the towns of Candia, Derry, and Londonderry. There is no routine surveillance for arboviruses in mosquitoes in the Conway area; however, deer and moose serosurveys confirm the presence of EEEv in all areas of NH including the most northern parts of the state. Prior to this case, the last human EEEv case in NH occurred in September 2009 with 11 additional cases occurring from 2004 (1), 2005 (7), and 2007 (3). Nationally, as of August 20, 2014, one other human EEE case has been reported from New York.
