The meeting was brought to order at 6:32pm.

**Public Hearing:** Case# 20-SR-02. Scenic Road Hearing for Eversource Energy. Members sitting: P. Behen, G. Bernstein, K. Fitzgerald, B. Hardwick, L. Heath, H. Kunhardt, L. Kunhardt.  
The area Arborist for Eversource, Dane D'Arcangelo, presents project. Powerline maintenance proposal encompasses tree work on twenty-three designated scenic roads in Frankestown. Notice was properly posted 2/7 and 2/11/2020. PB members conducted individual site walks. Discussion. All trees marked for removal suffer severe decay or appear dead. Many are mature white ash adversely impacted by invasive insect Emerald Ash Borer. Concern that tree removal will expand travel width of Dennison Pond Rd and desire to avoid same. Work anticipated to begin late June /early July. **Motion:** To approve Scenic Road Plan as proposed. (Kunhardt/ Hardwick) **Vote:** (favor) P. Behen, G. Bernstein, K. Fitzgerald, L. Heath, H. Kunhardt, L. Kunhardt, B. Hardwick. (7-0-0) Motion carries.
