Activity Logs 03/07/2023 – 03/22/2023

- 1. On 3/09 at 1648 hours received a report of a trespassing issue in the area of Mountain road. The complainant was contacted directly. The complaint involved unknown persons trespassing onto his private property that was posted property. Investigation is continuing.
- 2. On 3/10 at 1500 hours received a report of firearms being discharged in the area of Wilson Hill and the 2nd New Hampshire Turnpike (N). Upon arrival the area was checked and not contact was made. Further investigation followed and a residence has been identified. Investigation is continuing.
- 3. On 3/11 at 1755 hours received a complaint of firearms being discharged in the area of South New Boston road and the complainant advised that it was the neighbors and this is a neighborhood. State Police advised.
- 4. On 3/12 at 0738 hours received a report from a female victim of an alleged sexual assault that allegedly occurred at a residence on Potash road on the evening or early morning hours. The investigation is continuing.
- 5. On 3/12 at 1000 hours received a complaint from a resident residing in the area of Russell Station road. The complaint was relative to a suspicious person. In the early morning hours on 3/12 the complainant was awoken by what she described at footsteps on the rear deck area. The information was documented and extra patrols were done in the area. On 3/20 the complainant contacted this agency again and felt that this was a mistake, advising she felt the footsteps she heard were from a bear in the area. The complainant further advised that she took her birdfeeders down. Case closed.
- 6. On 3/13 at 1330 hours received a complaint of an alleged violation of a Stalking Order which had previously been issued by the Goffstown 9th Circuit court in the area of Pleasant Pond road. Further investigation into the complaint indicated that no violation was committed per the court order issued. The complainant was informed. Case closed
- 7. On 3/14 at 0406 hours received a report of a residential alarm activation in the area of Greenfield road. State police advised.
- On 3/14/at 0700 received a report of a disabled motor vehicle in the area of School House road. Upon arrival, directed traffic until the vehicle was removed by the wrecker company. Cleared

- 9. From 3/14 through 3/16, this agency received various calls for service pertaining to, trees on power lines, trees down, electrical lines down, one power pole down, roadway closures, vehicles off the roadway, disabled motor vehicles and vehicles stuck. As a result, numerous power outages occurred throughout this area and power was not restored for several days. This agency assisted the Francestown Highway Department and citizens throughout this severe weather incident.
- 10. On 3/15 at 0733 hours received a parking complaint in the area of Russell Station road. Upon arrival the vehicle had left the driveway. Information was obtained on the owner of the vehicle and later contacted. Case closed.
- 11. On 3/15 at 2025 hours received a complaint of a pending domestic issue in the area of Old County road (N). No violation had occurred at the time. State Police advised.
- 12. On 3/16 at 1627 hours received a complaint of a juvenile matter in the area of Potash road. Upon arrival the parent advised that there was a verbal altercation with his son, who then walked away from the residence. Further information was acquired and a search was conducted, which led to the location of the missing juvenile. The juvenile was escorted home to his parent and counseled. Cleared.
- 13. On 3/17 at 1453 hours received a residential alarm activation in the area of Poor Farm road. Prior to the arrival, the security alarm monitoring agency advised to disregard.
- 14. On 3/18 at 0035 hours received a report of a domestic disturbance in the parking lot of the Francestown Police department. This issue was reported to have started in Peterborough and Peterborough police responded to the scene of the Big Apple. After the initial investigation, both parties involved were released. At the request of State police, Peterborough police responded with State police arriving shortly after. After the investigation was conducted at the scene one subject was arrested and transported for a domestic violence violation.
- 15. On 3/18 at 1636 hours received a medical emergency in the area of King Hill road for a male experiencing chest pain. Emergency services responded and assisted the patient.
- 16. On 3/19 at 1636 hours received a complaint of a tree on the wires in the area of South New Boston road. It was reported that trees and wires were down and were not requesting law enforcement to respond.
