## Activity Logs <u>7/22/2021 – 8/2/2021</u>

- 1. On 7/22 at 0230 hours received a complaint of residential alarm activation in the Bible Hill road area. State Police responded and was found to be false.
- 2. On 7/21 at 1840 hours received a complaint of a suspicious vehicle in the area of 82 Clarkville road. It was reported that an older gentleman drove past the residence in a silver SUV and was taking photos. The complainant was not able to obtain any license plate of said vehicle. Case pending.
- 3. On 7/23 at 1533 hours received a complaint of criminal trespass at a residence located of Oak Hill road. The investigation was initiated and the status of the investigation has been suspended.
- 4. On 7/24 at 1312 hours responded to Main Street for a medical emergency for an elderly patient that was conscious but not alert. Assisted with traffic control and cleared after medical assistance was completed.
