## Activity Logs 8/3/2021 - 8/20/2021

- 1. On 8/3 at 1141 hours responded to 87 Greenfield road to assist a citizen on motor vehicle lock-out. Provided assistance and cleared.
- 2. On 8/4 at 2128 hours received a report of a stray feline in the area of 33 Mountain road. Animal control officer notified.
- 3. On 8/4 at 2107 hours received a report of a single motor vehicle collision in the area of 37 2<sup>nd</sup> New Hampshire Turnpike (S) a motor vehicle into a ditch. State Police advised.
- 4. On 8/6 at 1500 hours received a report of an aggressive canine in the Todd road area and that the victim had been bitten. Responded to the location and contacted the owner of the canine. Warning issued for unrestrained canine. Further that the canine was to be guarantined for ten (10) days. Cleared.
- 5. On 8/7 at 1030 hours received a report of a citizen requesting assistance relative to a criminal threatening and harassment counter complaint. Both parties who were verbally aggressive were separated. The investigation indicated that a verbal dispute occurred at the local transfer station on Todd road. No criminal charges were filed against either party involved at this time. Cleared area.
- 6. On 8/7 at 1100 hours responded to 365 East road to assist a citizen with a VIN verification request. Assisted citizen and cleared.
- 7. On 8/8 at 1153 hours received a request for a welfare check in the area of Hillside Lane senior citizen. Upon arrival into the area the citizen was located operating their vehicle. The citizen was asked to contact their relative in New York who was the complainant. Cleared.
- 8. On 8/8 at 1925 hours responded to Greenfield for a mutual aid call with Greenfield police in the area the Ted Trails off Mountain road for a report of a hiker with an unknown medical condition. The female caller was located and medical attention provided. Cleared.
- 9. On 8/10 at 1759 hours received a report from a citizen of an expired fox in the area of 358 new Boston road and would like it removed. New Hampshire Fish and Game advised.

- 10. On 8/11 at 1705 hours received a report of wires down in the roadway in the area of 105 Old County road (N). Responded to area and confirmed that a large cable wire had been dislodged and was a traffic safety issue. The cable company was notified and prioritized the repair. Cleared.
- 11. On 8/14 at 1212 hours received a report of residential alarm activation in the area of Bible Hill road. Upon arrival the residence was found secure and the owner was contacted and updated. Cleared.
- 12. On 8/4 at 1222 hours received a report of a motor vehicle complaint of a black colored mid-sized SUV coming out of Greenfield on Route 136 eastbound. Agency tied up on residential alarm activation, information transferred to surrounds agencies.
- 13. On 8/15 at 1006 hours received a mutual aid request by Greenfield police for assistance with a missing eleven year old child in the area of Crotched Mountain who was last observed near the Gregg Trail area. While assisting other emergency services that child was located. Cleared.
- 14. On 8/15 at 1800 hours received a complaint of canines barking in the area of Oak Hill road. Upon arrival confirmed that the canines were barking in the area of 45 Oak Hill road. The owner was eventually contacted and advised of the complaint. Cleared.
- 15. On 8/16 at 1452 hours received report of a stray puppy in the area of Bible Hill road. Animal control officer contacted and given all the complainants information.
- 16. On 8/17 at 0730 hours received complaint of an animal that had been hanging around the owners resident for the last couple of days and was concerned. Responded to the area and checked the area with the complainant. Negative contact with animal. Cleared.
- 17. On 8/17 at 1341 hours received complaint of a female cat that had a litter of kittens on her property in the area of Scoby Road. Resident did not know who owned the feline and requested assistance with removal. Animal control notified.
- 18. On 8/18 at 0945 received a complaint from a citizen in the Schoolhouse road area. The complaint was relative to receiving a solicitation phone call message from a known person and did not wish this to receive the calls. This agency acquired all the pertinent information, contacted the person making the calls and advised to discontinue making any calls to the complainant. Cleared.

- 19. On 8/18 at 1340 hours responded to the area of Scoby Wood Lane for a report of a prior theft. Upon arrival and further investigation the complainant stated that two kayaks, to kayak paddles and two fishing poles/reels were taken from his residence/porch area. During the investigation and a search of the area the missing items were located at a camp being rented on Scoby Pond. The four occupants of the rented property were confronted with the fact that the reported stolen items were located on the property they were renting. The stolen items were positively identified and were returned to the complainant. Cleared. Investigation continuing.
- 20. On 8/19 at 0930 received a report of a missing feline, last seen in the area of 732 Bible Hill road. The feline has been missing for 4 weeks and is described as being white and orange in color, short haired and micro-chipped. Anyone possibly observing this animal is asked to contact this agency.
