Activity Logs 8/21/2021 - 9/8/2021

- 1. On 8/21 at 1445 hours received a report for a Medical/Lifeline at 631 Dodge Hill road. Upon speaking with the alarm company and subscriber it was determined to be false. Cleared.
- On 8/21 at 1945 hours received a report of a business alarm activation at 27 Main street. Upon arrival the alarm was determined to be false. Cleared.
- 3. On 8/22/2021 at 1411 hours received a complaint from a subject located on Pleasant Pond road of harassment. The complainant responded to the police station and met with the investigating officer. The initial investigation indicated that the complaint was unfounded.
- 4. On 8/22/2021 at 1503 hours received a complaint of theft in the Mountain road area. An investigation was initiated and is ongoing at this time.
- 5. On 8/23/2021 at 1300 hours responded to a complaint of a roadway obstruction on New Boston. Upon arrival no obstruction was located. Cleared.
- 6. On 8/24/2021 at 0800 hours a complainant came to the station to report an Indecent exposure-lewdness complaint. The investigation into the possibility of criminal charges is pending. Investigation is continuing.

This agency met with the child and parents where suggestions were made so this would not occur again. All units cleared.
- 19. On 9/4/2021 at 1821 hours received a medical emergency ion the area of Scoby road for a fifty-nine year old female who had been thrown from a horse, having sustained a laceration and difficulty breathing. Upon arrival the victim was assisted by Emergency Services. Cleared.
