## **Police Log**

**8/23/2020 – 9/24/2020**

1. On 8/23/2020 at 1650 hours, Fracestown Police conducted a motor vehicle stop along Main Street in Fracestown. The driver, Richard Stapleton, 30 years old of Bennington NH, was charged with Driving While intoxicated. The vehicle, a 2006 Jeep Cherokee, had also been involved in a previous motor vehicle accident, striking a telephone pole in Milford, NH. The vehicle had left the scene of the accident, where it was subsequently stopped by Fracestown Police. Milford Police responded to the scene. Stapleton was charged by Milford Police with Conduct After Accident. The vehicle was towed to Mike's Towing.
2. On 8/24/2020 at 1713 hours, police responded to the area of South New Boston Road, for a residential alarm. All was secure upon arrival.
3. On 8/26/2020 at 1441 hours, police responded to the intersection of 2<sup>nd</sup> NH Turnpike (S) and Poor Farm Road, for a motor vehicle accident. Driver James Deforest, 55 years old of Hillsborough NH, was driving a Granite Street Concrete truck, turning onto 2<sup>nd</sup> NH Turnpike (S), when it struck a utility trailer operated by Michael Gagnon, 51 years old, of Merrimack, NH. No injuries were reported, and vehicles were driven from the scene.
4. On 8/27/2020 at 1612 hours, police responded to the area of Main Street, for an E911 call. Call was found to be accidental, and all was fine upon arrival.
5. On 8/30/20 at 1113 hours, police responded to the area of Mountain Road and Back Mountain Road, for a car that had driven off the road and into a ditch. Upon arrival, the driver Richard Baldwin, 72 years old, of Deering, NH, driving a 2014 black Mazda, said he had fallen asleep. He was transported via ambulance to Monadnock Hospital. The car was towed by Mike's Towing.
6. On 9/5/20 at 1616 hours, police responded to a residence on Old County Farm Road (N) to check the welfare of a resident. All was fine upon arrival.
7. On 9/8/20 at 2325 hours, police responded to the area of Clarkville Road, for a reported juvenile that had left the residence. Fracestown Police responded to the scene. The juvenile subsequently returned home without incident.
