8/24/2019 - 9/19 /2019

- 1. On 8/24/2019 at 0802 hours, police investigated a report of a vehicle operating erratically on the Bennington Road. The driver was checked by the Crotched Mountain Ski area, and found to be fine.
- On 8/24/2019 at 1007 hours, police investigated a report of a barking dog on Bible Hill Road.
- 3. On 8/24/19 at 1055 hours, police responded to the area of Bennington and Mountain Roads, for a single motorcycle accident. Driver Charles Cushing of Methuen, MA lost control of his motorcycle. He and passenger Ashley Hillilwell of Derry, NH fell onto the roadway and sustained injuries. Both were transported via ambulance to Monadnock Community Hospital for treatment.

Cephas and a passenger were transported via ambulance to Monadnock Community Hospital for treatment.
- On 8/26/19 at 1607 hours, police investigated a report of a suspicious vehicle, described as a white SUV, in the area of the 2nd NH Turnpike (N) and Wilson Hill Road. Vehicle was gone upon arrival.
