- On 9/10/2021 at 0800 hours received information of an accidental discharge of a firearm located in the area of 2nd New Hampshire Turnpike (N). Further investigation confirmed the accidental discharge with no injuries. Cleared.
- 2. On 9/10/2021 at 2200 hours received a report of loud noise in the area of Pleasant Pond road. Investigation indicated that the responsible person(s) live in the immediate area and this agency is working with the reporting party to identify the person(s) responsible pertaining to the Disorderly Conduct statute. Cleared.
- 3. On 9/11/2021 at 1639 hours responded to a medical emergency in area of Main Street for a nine-three year old female for difficulty breathing. Emergency services responded to assist the patient. Cleared.
