## 12/17/2019 - 01/17/2020

- 1. On 12/17/2019 at 0700 hours, police responded to a reported chimney fire with Francestown Fire Department, at 157 Main Street.
- 2. On 12/17/2019 at 1134 hours, police responded to a motor vehicle accident on the Greenfield Road by Old County Road South. Driver Cassandra Wright, 23 years old of Greenfield NH, lost control of her Toyota Corolla, and struck a telephone pole. She was transported to Monadnock Hospital with minor injuries. The vehicle was towed from the scene.
