1/24/2020 - 2/20/2020

- 1. On 1/24/2020 at 1718 hours, police responded to a residential alarm on the 2nd NH Turnpike (N). All was fine upon arrival.
- 2. On 1/27/2020 at 1031 hours, police responded to a request for a civil standby for belongings on Dennison Pond Road
- 3. On 1/29/20 at 1435 hours, police investigated a report of a vehicle passing a school bus, on in the area of Bennington and Mountain Roads.
- 4. On 1/30/2020 at 1152 hours, Francestown Police responded to a residence on Pleasant Pond Road, for a domestic verbal dispute. Both parties were spoken with, and the officer cleared.
- 5. On 2/3/20 at 1154 hours, Francestown Police responded to the Crotched Mountain Resort Golf Course, to assist with a motor vehicle lockout.

Driver Karlyn Berry of Raymond NH, 17 years old, driving a 2003 Ford F-150, had skidded off the road due to snow and ice. The vehicle struck a tree, and continued down the embankment. She was not injured, but was transported via ambulance to Monadnock Hospital to be checked. Mike's Towing remove the truck from the scene.
- 14. On 2/13/2020 at 1630 hours, Francestown police assisted Hooksett Police, requesting a welfare check of a resident on Bible Hill Road. Upon investigation, all was fine. Hooksett PD was advised.
