Activity Logs 3/25/2024 – 4/7/2024

- On 3/26 at 0827 hours received a medical emergency in the area of Schoolhouse Road road for a sixty-eight-year-old male experiencing general weakness. Emergency Services arrived and assisted the patient. Cleared.
- 2. On 3/27 at 0959 hours received a medical emergency in the area of Greenfield road for a sixty-eight-year-old male experiencing abdominal pain. Emergency Services arrival and assisted the patient. Cleared.
- 3. On 3/27 at 2047 hours received a complaint of a suspicious vehicle being parked in the area of the 2nd N.H. Turnpike (S) earlier in the day in the school parking lot. Upon receiving this information, the owner of the vehicle of the vehicle was identified who had recently purchased land in the area.
- On 3/28 at 0546 hours received a report of an electrical transformer on fire in the area of the 2nd N.H. Turnpike (S). Keene Mutual Aid advised.
- 5. On 3/28 at 1340 hours received a report of a suspicious caller to a resident residing in the area of Russell Station road. The caller claimed to be a medication provider and wanted the complainant to call a number due to a question on her account. The complainant was advised that this was a scam and not to return the phone call.
- On 3/28 at 1515 hours received a report of a safety concern where trees had fallen and damaged a fence in the area of the Towns tennis courts on Old County Road (S). Francestown Highway advised.
- 7. On 3/31 at 0048 hours received a suspicious activity complaint in the area of Trailside Lane. The reporting person indicated that she could hear banging outside her door as if someone was trying to enter her residence. State Police advised.

- 8. On 3/31 at 0911 hours received a complaint of an abandoned motor vehicle in the area of Greenfield and Birdsall road. Upon further review the vehicle was found to be removed.
- 9. On 4/1 at 0800 hours found property was dropped off at the police station. The item was a Garmin Edge remote which is utilized while bicycling. It was reported that this time was found on one of the hiking trails in Francestown. This item was posted on the town's and police department's website and on Face-Book.
- 10.On 4/2 at 1110 hours responded to a residential alarm activation in the area of Todd road. Upon arrival at 1112 hours contact was made with the resident. It was confirmed that the activation was false. Cleared.
- 11.On 4/3 at 1128 hours received a request for a well-being check on a resident residing on Bennington road. It was reported that the home-owner had other people occupying their residence and was requesting that they vacate the property. Further investigation was initiated and the complainant was advised that a civil proceeding would need to be taken to resolve this issue. Cleared.
- 12.On 4/3 at 1705 hours received a fraud report from a citizen residing on Main street. It was reported that the complainant's Experian Credit account had been compromised for a large amount of money by unknown person(s), The Experian fraud department informed the complainant to report this fraud to the local police department. The report has been placed on file for future reference.
- 13.On 4/4 at 0910 hours, under a mutual aid request from New Boston Police department this agency responded to the area of Scoby road. The purpose was to contact the owner of a vehicle which was reported to have been involved with a conduct after an accident in New Boston. The New Boston officer was assisted at the scene while an interview with the vehicle's owner was initiated. Cleared.
- 14.On 4/4 at 1531 hours received a report of electrical wires in the roadway in the area of Muzzey road. Eversource was advised and traffic cones were placed on the road.

- 15.On 4/5 at 1648 hours received a report of a well-being check for a resident who allegedly was threatening suicide and also possessing a firearm. It was further reported that the person was not home, operating a vehicle and was communicating through texts to another family member. At 1715 hours a broadcast was put out to area units on the concern and to check the welfare. It was believed that the person was in Peterborough at the time, however this person was located at 1759 hours in Goffstown and was taken into custody. The concerned family member was contacted and advised the party of concern was safe and had been taken into custody. Cleared at 1805 hours.
- 16.On 4/5 at 0716 hours received a medical emergency in the area of Gerrish road for a ninety-three-year-old male unconscious but breathing. Emergency Services responded to assist the patient.
- 17.On 4/6 at 0812 hours received a medical emergency in the area of Gerrish road for a male who had fallen. Emergency Services responded to assist the patient.
- 18.On 4/7 at 1100 hours assisted a resident with the taking of fingerprints for possible volunteer position. Cleared.
- 19.On 4/7 at 1550 hours received a complaint of two OHRV's operating on the roadway in the area of Birdsall road. Upon arrival at 1556 hours the entire length of Birdsall road and connecting roadways were checked without any contact.
