- 2. On 4/26 at 0728 hours received a complaint of a residential alarm activation in the area of Dennison pond road. Upon arrival contact was made with the individual on the property and it was determined to be false. Cleared.
- 3. On 4/26 at 1557 hours received a report via 911 of an unwanted subject in the area of Candlewood Hill road. The white male subject entering the complainant's garage and removing items. State Police advised.
