## Activity Logs 6/6/2022 - 6/20/2022

- 1. On 6/6 at 0900 response from an alleged domestic disturbance in the area of Old County road south. One person involved responded to the police station where the initial complaint was taken. Upon further investigation, no physical abuse was found by either party involved. The complainant was assisted in contacting and meeting with the Monadnock Crisis and Victim Prevention Center case worker out of Keene N.H. Civil court action was pending.
- 2. On 6/8 at 0444 hours received a residential alarm activation in the area of 2<sup>nd</sup> New Hampshire Turnpike. State Police notified.
- 3. On 6/8 at 1000 hours received a complaint of a scam involving the theft of money from the victim's bank account. At the time the victim was utilizing his home computer, received a "Norton Alert" and the computer locked up. Victim was further instructed to contact a number which he did. After speaking directly to an unknown suspect, several transactions from his bank account were made. The felony theft remains under investigation.
- 4. On 6/8 at 0917 hours this agency received Domestic Violence court orders to be served to an individual, who was met at the police station. The court orders were issued and followed through as required.
- 5. On 6/10 received a request for a welfare check of a citizen residing in the area of Bennington road. Mutual aid from Greenfield Police responded contacting the citizen who was found to be fine.
- 6. On 6/10 at 1249 hours received a complaint of illegal dumping in the area of Muzzy road. Upon further investigation it was reported and confirmed that an unknown person(s) illegally dumped various pieces of old sheet-rock, sheet-rock plaster and five (5) gallon buckets onto private property. Investigation continuing.
- 7. On 6/12 at 1007 hours received a report of a criminal mischief complaint relating to a boundary line dispute between two neighbors in the area of King Hill road. Upon arrival the investigation as follows. It was determined that one of the neighbors had trenched directly on the property line, encroached into the complainant's property and severed the electronic canine fencing. Investigation is on-going. Cleared.

- 8. On 6/13 at 0930 responded to the area of 2<sup>nd</sup> New Hampshire Turnpike (s) to assist a citizen with the VIN inspected. Completed same and cleared.
- 9. On 6/13 at 1002 hours responded to a residential intrusion alarm in the area of the 2<sup>nd</sup> New Hampshire Turnpike (s). Upon arrival and checking the residence the home-owner was located inside the residence. Alarm activation was owner error. Cleared.
- 10. On 6/16 at 1327 hours received a report of an attempted scam. The resident from the Poor Farm road area reported receiving a call from the Publishers Clearing House. The complainant stated that no information was given to the caller and wanted this information on file.
- 11. On 6/16 at 1530 hours received a call from Antrim Police department informing this agency of a criminal threatening issue. The juvenile who was on a class trip at Cannon Mountain at the time. The juvenile, who resides in Francestown had sent a "snap-chat" while riding the tram is all alleged to have said "little do they know I have a bomb". The parents of the juvenile were contacted for a meeting and the investigation into the matter is on-going. The school district was also contacted on this issue.
- 12. On 6/17 at 0720 hours received a report of cows near the roadway in the area of 510 New Boston road.
- 13. On 6/17 at 1730 hours responded to the area of Russell Station road to assist a citizen with a VIN inspection. Completed this request and cleared.
- 14. On 6/17 at 2000 hours received a call for an injured bird in the area of Bennington and Pleasant Pond road. Upon arrival, an owl was located and appeared to have a wing injury and transported to the Wings of Wildlife in Henniker N.H. for rehabilitation.
- 15. On 6/19 at 1146 hours received a complaint of criminal trespass and criminal mischief complaint in the area of King Hill road. This complaint involved the cutting of a large tree on the complainant's property without authorization. The suspects in this investigation were identified as a neighbor, the crane operator of Able Crane Company of 12 Star Drive Merrimack New Hampshire and two other suspects who were involved at the time. The investigation into criminal charges are continuing at this time.
