Activity Logs 11/01/2023 – 11/20/2023

- 1. On 11/1/2023 at 1328 hours received a call for a suspicious person walking a canine in the area of Old County road north. State Police advised.
- 2. On 11/3/2023 at 1052 hours received a request for a VIN verification from a citizen in the area of Bible Hill road. Upon arrival, conducted the VIN inspection and then cleared.
- 3. On 11/8/2023 at 1630 hours responded to a report of a single vehicle motor vehicle collision in the area of 2nd New Hampshire Turnpike (S) with no injuries. Upon arrival at 1628 hours the operator was identified. The investigation identified the operator as one Randy L. Vaillancourt age 46, of Bedford New Hampshire, was not injured. The investigation indicated that the vehicle, a 2015 Ford F-250 being driven by the above operator was eastbound. At this time the vehicle gradually veered off to the right-hand side of the roadway and into the embankment where it came to final rest. It was determined that the contributing factor of the collision was a result of fatigue of the operator. The vehicle was towed from the scene by Mike's Towing of Bennington N.H.
- 4. On 11/9/2023 at 0509 hours received a call for a medical emergency in the area of Wilson Hill road for a sixty-nine-year-old female. Emergency services responded and assisted the patient.
- 5. On 11/9/2023 at 1656 hours received an E-911 hang-up call in the area of Bible Hill road. State Police advised.
- 6. On 11/11/2023 at 0320 hours received a report of suspicious lights in the area of 2nd New Hampshire Turnpike (N). The complainant stated that a series of red colored lights were blinking in the wooded are near their residence. This agency followed up with the complainant on 11/11/2023 at 1145 hours. After further investigation it was believed that this was a result of the reflection from the towers near the airport or the lights from the windmills in Antrim. Cleared.
- 7. On 11/11/2023 at 1400 hours received an alarm activation at a business in the area of Main street. Upon arrival at 1402 hours the building was found secure. Cleared.

- 8. On 11/14/2023 at 1343 hours received a neighborhood dispute in the area of Eastside Lane. The complainant was contacted and further investigation was initiated. It was determined that part of the complaint was a civil issue and both parties were advised to contact the Condominium Association. The primary complaint, disagreements between the two tenants relative to canines running at large and allegedly being aggressive was unfounded. Cleared.
- 9. On 11/14/2023 at 1839 hours received a report of a domestic disturbance in the area of Todd road involving a parent and family member. State Police advised.
- 10.On 11/15/2023 at 1600 hours received a complaint of fraud. The complainant reported that in the month of January and July of this year she attempted to rent a vacation property in Meredith, New Hampshire. After placing deposits down, it was later found out that a fraud had taken place and the location was not owned by the subject claiming to own the property and was a private residence. The Meredith Police Department confirmed that these scams were occurring in the area. They were provided a copy of this agency's investigation report.
- 11.On 11/16/2023 at 1747 hours received a report of a motor vehicle collision, vehicle verses a whitetail deer in the area of Greenfield and Reid Road. State Police advised.
- 12.On 11/18/2023 at 1200 received a report from a resident of a possible illegal poaching of a moose. The complainant stated that the remnants were located in a wooded area in the town of New Boston. Further investigation revealed that the remnants were not from a wild moose but a domesticated farm animal. It was further established that the complainant had previously report this to the New Hampshire Fish and Game Department and they had determined the same facts. Cleared.
- 13.On 11/18/2023 at 0100 hours received a report of a motor vehicle collision, vehicle verses a whitetail deer in the area of New Boston and Chandler road. State Police advised.
