12/4/2023 – 12/31/2023

1. On 12/5/2023 at 1310 hours received a request for a VIN verification in area of Old County road area. Responded to the location and completed same. Cleared.
2. On 12/5/2023 at 1530 hours received an intake complaint from DCYF relative to an alleged child abuse report. Coordinated meeting with case worker for further investigation into the complaint.
3. On 12/6/2023 at 1513 hours received a residential alarm activation in the area of Mountain road. Prior to arrival received cancellation. Cleared.
4. On 12/6/2023 at 2059 hours received a medical emergency in the area of New Boston road for a four-month-old for difficulty breathing. Emergency services responded and assisted the patient.
