Correspondence from Betsy Hardwick raised the question of the possible need for Alteration of Terrain permits for projects on Main St., Woodward Hill Road and Stevens Road.

The Board would like to meet with John Kendall, Code Enforcement, on the 28th of December to get an update on the alleged violation of Francestown Zoning Ordinance 3.9.1. regarding in-home businesses on Perley Road and the junkyard issue on Old County Road North.

A motion was made by Mr. Kunhardt and seconded by Ms. Dixon to enter into a nonpublic session pursuant to RSA 91-A:3, II(d) at 7:08 pm. Kunhardt, Aye; Howell, Aye; Dixon, Aye **Motion passes.**
