The Town has received a donation from Ken & Cecily Houston in the amount of \$2,500 for deposit to the Public Assistance Trust Fund. The Board discussed the closure of recreation areas to avoid the transmission of COVID-19. The Board agreed to close the Town Beach and the Hard Court (skate board park) areas. Signs will be placed at the locations noticing the closure. It was also noted that the Rec Commission has postponed the opening of the Farmer's Market until May.

The Town's website was discussed, specifically the items being incorporated into the COVID-19 Neighbor 2 Neighbor program. It was decided to provide a bulleted list of resources and to notate those resources which are not provided by the Town.
