- 2. On 1/18 at 0854 hours received a residential alarm activation in the area of South New Boston road. Upon arrival the residence was found to be secure and the owner was not on the premises. Owner notified of the activation and cleared.
- 3. On 1/18 at 1727 received a request to conduct a well-being check on a resident in the area of Eastside Lane. State police advised.
- 4. On 1/19 at 1659 hours received a report of a conduct after a collision in the area of Todd road. Greenfield Police department responded to location under a mutual aid request and conducted the investigation.
