1. On 3/7 at 1226 hours received a report of a large amount of smoke coming from the area of Route 47, south of the ski area. Upon arrival the source was located and was found to be a controlled burn. Cleared.

Upon being taken into custody he was processed and then bailed with a Goffstown Court date of April 28, 2022 @ 8:15am and an additional Milford Court date of April 4, 2022 @ 9:00am.
- 4. On 3/9 @ 1651 hours received a report of a vehicle off the roadway with no injuries in the area of Bennington road near Abbott Lane. N. H. State Police advised.
