- 1. On 5/2 at 1140 hours responded to a medical call for a male patient have a diabetic reaction and being combative in the area of Pleasant Pond road. Upon arrival, assisted medical personnel until the patient was transported. Cleared.
- 2. On 5/4 at 0827 hours received an abandoned 911 hang-up call in the area of Red House road. Upon arrival met with the owner and everything confirmed to be fine. Cleared.
- 3. On 5/5 at1141 hours had some found property turned into the police station being a wallet. The owner was identified residing in Dunbarton, contacted and returned property. Cleared.
